NOTICE OF DECISION

A Public Hearing for Sandra Nierman of 106 Pond Street, Newton, NH (Map #04-Block 2-Lot 03) was held Monday, October 1, 2018 at 7:30 PM in the Town Hall, Newton, NH, to act on the request for a Variance of Newton Zoning Ordinance, Section XXVII (Wetland Zoning Ordinance), Paragraph #8.b (no building activity permitted with 50' of any poorly drained soil). The Board voted unanimously to approve the Appeal of Newton Zoning Ordinance, Section XXVII, Paragraph 8.b:

- Twenty four feet, seven inch variance on the Southeast side of property;
- Eleven feet, four inch variance on the Southwest side of the property.

Variance is based on a plot plan prepared by Paul Nichols, PE, LS dated May 31, 2018, job number 551-99.

Any person affected has a right to appeal this decision. If you wish to appeal, you must act within thirty (30) days of this notice. The necessary first step, before any appeal may be taken to the courts, is to apply to the Board of Adjustment for a rehearing. The motion for a rehearing must set forth all the grounds on which you will base your appeal.
