PUBLIC MEETING MINUTES

I. Call to Order

Foote were excused this evening as well as Selectmen's Secretary, Diane Morin.

Nonpublic Session under RSA 91-A:3 II (a) – (c) -HR Matters

Nonpublic Session under RSA 91-A:3 II (c)

Selectman Doggett moved to go into Non-public under RSA 91-A:3 II (a) – (c). Second by Selectman Gonyer with a unanimous roll call vote: Burrill – aye, Gonyer – aye, Doggett – aye.

Selectman Doggett moved to come out of non-public at 7:15 pm. Selectman Gonyer seconded with a unanimous roll call vote: Burrill – aye, Gonyer – aye, Doggett – aye.

Selectman Doggett moved that the Board just came out of a non-public session under RSA 91-A: 3 II (a) - (c) and that they keep all matters discussed confidential until in the opinion of the majority of the Board the circumstances no longer apply except to announce a merit increase for Gail LeBlanc, Planning Board from Grade XIV Step 7 to Grade XIV Step 8, effective November 26, 2017; to take Gail LeBlanc off of probation as Board of Appeals Secretary, and change her to permanent status, with a pay increase from Grade IX Step 10 to Grade X Step 9, effective November 26, 2017; pay increase for Lawrence Foote as EMD Director from Grade XVI Step 9 to Grade XVI Step 10, effective November 26, 2017. Second by Selectman Gonyer with a unanimous vote.
