Approval of Minutes

Selectman Burrill made a Motion to approve the Minutes for August 20, 2018, and Ms. Kuzmitski seconded the Motion. Motion was unanimously approved.

Senior BBQ – September 13, 2018

62 tickets for the Senior BBQ have been sold as of this date. Nancy Wrigley, Town Administrator, will purchase food for 75 people. \$200 has been approved for food purchases. Food will include hamburgers, hot dogs, rolls, chips, water, lemonade, ice cream, ketchup, mustard, relish. Chief Jewett said there is room in the Station refrigerator to store the food until the event. The grill is being delivered at 1:00 p.m. After 3:30 on September 16, Chief Alcaidinho will transport the grill to Memorial School for Olde Home Day. He will also transport tables and chairs.

Mark Holms will provide entertainment. Selectman Burrill will provide audio equipment. Items will be raffled – names will be written on guests' tickets.

The BBQ will be from 4:00 p.m. to 6:00 p.m. Volunteers should be there by 3:00 p.m.

Food will be provided by the Fire Department Ladies Auxiliary (bake sale), the Fire Department (linguica and corn), the Lions Club (burgers and hot dogs), Chubs (kettle corn, fried dough, French fries), Kona (ice cream), and Eastern Seaboard (popcorn, cotton candy).

Red Sox Wally is confirmed for arrival at 1:15 p.m. He will change in Station 2 or the Command Vehicle. Irish Step Dancers will perform at noon, followed by Empower Martial Arts and the canine demonstration. Tomas will be doing caricatures throughout the day.

Grand Rental will arrive at 3:30 p.m. on Friday with a 16x16 dance floor, 20x20 canopy for the bands, and the dunk tank. Selectman Burrill will ask the Fire Department to fill the dunk tank with water.

We need a big-ticket item for the raffle – a \$5 ticket. Chief Jewett will ask Home Depot if they can donate a grill or other big item. He will also ask for donations from Ravensburger Puzzle.

Vice Chair Burrill made a Motion to spend not more than \$100 for a putting green that will be used that day and retained for Recreation Commission inventory. Selectman Burrill seconded the Motion. Selectman Burrill amended the Motion to spend not more than \$150. Vice Chair Burrill seconded the amendment.

Do we need Election Day signage? No, ballot tenders will remind voters that Olde Home Day is September 15.

Cones or ropes are needed for a walkway to the activities. Selectman Burrill will call the Church to ask if they can accommodate overflow parking. Volunteers needed:
