### GALE LIBRARY REPORT

There has been a lot of activity going on at the library this year. There have been many programs and events for patrons of all ages. We are now linked to the official Town of Newton website. This site will provide news and event information regularly.

The year started off with a Winter Reading Program for children entitled, Snow is Falling, Books are Calling. Patrons read and received prizes for reaching their goals.

This year's Summer Reading Program, Camp Wannaread, had 110 children registered. There were 890 books read and many prizes given to the participants. Gratitude is given to Mrs. Sue Mears, our Children's Librarian and Assistant Director, for her outstanding planning and creativity. A Kids, Books, and Arts grant of \$325 was obtained by Mrs. Mears from the NH State Council on the Arts, the NH Library, the Byrne Foundation, the Cogswell Benevolent Trust, and the Madeline G. von Weber Trust. The money received allowed the performance of Jody Gourlay to sing and dance with the children on a camping theme.

For our adult readers we held a Cabin Fever contest to chase away the winter blues. This was a fun way to pass the time during the cold weather months.

Elly Becotte of Kingston, NH delighted audiences with her slide show programs. Her presentations are very informative and well-attended.

Tom and Nora McElroy of the Newton Greenhouse gave a Planning Presentation to kick off the gardening season. Techniques and tips on planting were given to attendees.

National Library Week was celebrated from April 10-16 this year. During this week, the Friends of the Gale Library sponsored the annual Art Show and Open House. Local artists displayed their works and met other community members.

The annual Basket Raffle and Christmas Party were held on Sunday, December 18 with a special visit from Santa!

Various other programs were given throughout the year with the assistance of staff and parents. There have been many volunteers who contribute and donate to the ongoing works of the library.

The Friends have shown tremendous generosity in assisting the library. They have purchased passes to the New England Aquarium in Boston, an air-conditioner, supplied seasonal decorations, purchased books for high school summer reading, bound a rug for us, and provided computer chair mats. In addition they have purchased rope for our flag, a DVD with VHS player and a 27" television for the children's room. They hold fundraisers and book sales to provide the extras to supplement our budget. There is so much that they do throughout the year. The trustees, staff and patrons appreciate all their efforts for the library.

An Outdoor Reading Garden was established for reading and craft sessions seasonally. This new area has a picnic table and flowers to relax and enjoy.

The front porch and railing was painted. New traction treads were installed on the steps for safety. A new set of steps for access through the basement was constructed.

Projects are ongoing and we will continue to update as necessary.

The library continues to be a great value to those seeking novels, books on CDs and tape, movies, magazines, music, and a variety of non-fiction subjects. We have been fortunate to receive many donated materials and financial assistance throughout the year. New items have been purchased for circulation. There is something for everyone. ### **BUILDING INSPECTOR**

#### DEPARTMENT OF BUILDING SAFETY

The building industry was very busy during the year of 2005. Many sub-divisions completed the planning phases early in the year and are in the building process. We are anticipating a slower building season for the year of 2006. We are hoping to put more time into our training efforts to obtain more certifications. As a result, that will help to create a safer community and lower the cost of the homeowner's insurance rates for new construction.

The team approach in the Department of Building Safety has worked well for the year of 2005. Ron Lemere is continuing as the primary Assistant Building Inspector. Kris Emerson is continuing as an Assistant Building Inspector with responsibilities in structural inspections and plan reviews. Mike Hartnett has been appointed as an Assistant Building Inspector with responsibilities in plumbing, gas, and mechanical inspections. All the inspectors have life long experience directly related to the building construction, and maintenance industries.

# **ROAD AGENT**

This was another productive year for the Highway Department. We all worked hard and made a lot of changes around the town.

Some of these changes consisted of widening the shoulders on Smith Corner Road. The width of the road was 15 feet – 17 feet wide; now after the work has been completed it varies from 22 feet – 24 feet wide. While doing so, we replaced three culverts with head walls and we had Smith Corner Road reclaimed and repaved from Brimstone Circle to Williamine Drive. We also reconstructed the Pond Street and Whittier Street intersection, making a potentially dangerous intersection into a safe T-intersection. This intersection was an ongoing problem which needed and received a major improvement.

The road crew had another busy season as well. They worked hard at keeping up with the overgrowth caused by Mother Nature. This task was difficult because of the extremely wet spring and summer seasons. The crew also had time to clean out drainage swales, culverts and catch basins.

The Highway Department still has safety issues that I am working on for next year. Maple Avenue and Heath Street are just two of the many roads that are on the top of the list, as well as New Boston Road needs more work.

The Highway Department would like to thank the residents of Newton for your continued support.

### CONSERVATION COMMISSION

It's hard to believe that another year has come and gone. The Conservation Committee has completed many achievements this past year. Our committee is comprised of volunteers that are appointed by the selectmen. According to state law, it is our responsibility to protect the natural resources of the town. Our membership is made up of six regular members, three alternates, and one Selectmen Ex-Officio representative. It is because of their positive energy and innovative ideas that we have continued to protect our natural resources. Our members have a wide range of knowledge concerning wildlife, vegetation, shoreline and wet soil issues and are not afraid to think out of the box to accomplish the tasks we are presented with.

The Conservation Committee has the important assignment concerning the proper utilization and protection of the natural resources and protection of watershed resources, including but not limited to shoreline protection, wet soil issues, site walks (when responding to citizen concerns), and endangered species protection. We continue to work with the State Wetland Bureau concerning any issues in our town as well as our input on all dredge & fill permit applications. The Scenic Roads in town also come under the charge of this Commission, as described in RSA 231:157 and RSA 231:158. The list of Scenic Roads are, Gale Village Road, Currierville Road, Maple Avenue, Goulds Hill Road, Heath Street, Bartlett Street and Thornell Road. The various boards in our town continue to keep us informed on issues and permits that come before them. We enjoy the good working relationship with all the town boards and committees.

One of our accomplishments this year has been under the direction of conservation vice chairperson, Alicia Raddatz. In May of 2005, we hosted our first identification process of bio monitoring of wet soil areas on the Busch Farm, and invited residents (adults and children) to get involved. It was a great success. We will expand this to other areas in town. Our goal is to include students from Memorial School, Boy Scouts, and Girl Scouts in our next bio-monitoring event. We invite participation by all, and guarantee that it will be a fabulous learning experience, (and fun for all ages).

Members of the conservation commission were able to participate in the 2005 Law Lecture Series. This series included three lectures: 1. Off-Site Exactions and Impact Fees, 2. Ethics for Lane Use Board Members, 3. Land Use Regulation. Our members continue to attend informative and education meetings, when ever possible.

The Conservation Commission was invited to participate in a local community event that was sponsored by the School Nurses in the Town of Newton and Town of Kingston. The purpose of this event was to educate our youth in health, nutrition and exercise. Our committee was able to provide a slide show of Newton Conservation and Recreation Land. We supplied town maps showing conservation land that would be great for hiking, cross-country skiing, exercising your dogs, bird watching, wildlife observation or just a simple picnic. The public is encouraged to use and enjoy this open space. One of our largest parcels is the Busch Farm that has over 47 acres to explore. This area is open to the public and includes off street parking. The easiest access is from Rte 108 (north of New Boston Road), on the right side by the pipe gate. We are working on getting a sign at the entrance.

Of course we are very proud of the conservation easement on Hidden Acres Farm, located on Thornell Road. As a result of years of hard work by current and past conservation committee members, selectmen, and the landowner Forrest Reynolds, this easement was the conclusion of our application to the Land and Community Heritage Investment Program, (LCHIP). One of the requirements of this program was the formation of the Stewardship Committee. This committee was appointed by the Selectmen and is comprised of five members that remain on the committee with staggering terms as follows: Mary Marshall-Chairperson expires in 2006, Nancy Slombo-Vice Chair expires in 2007, Mike Seacamp-Treasure expires in 2008, Trisha McCarthy-Secretary expires in 2009, and Pat Wonson who expires in 2010. This is a wonderful piece of Newton History that we have the ability to protect. We continue to work with the homeowner, (Mr. Reynolds) and monitor the easement and activity on it.

On a sad note, the Conservation Commission lost a very long time member Steve Cushing. Steve retired from the commission earlier this year. He is an enormous loss to the commission. His knowledge and expertise is greatly missed. Steve was instrumental in many of the accomplishments of protecting our natural resources, including but not limited to the acquisition of the Busch Farm and the Hidden Acre Easement. He volunteered his time, tools, equipment and vehicles, without hesitation. The immeasurable energy he had overflowed onto the rest of the commission, making us a spectacular team. Of course we realize, that life goes on, (even after you leave the conservation commission), and we sincerely wish him the best that life can offer.

This committee meets on the first and third Thursdays of each month. The meetings are held in the rear of the Town Hall at 7:30pm. All meetings are open to the public, and we encourage anyone that is interested to attend. Feel free to log onto to the town web site for access to minutes of our meetings.

We look forward to another prosperous year, and encourage your input.
