FIRE DEPARTMENT

To The Citizens and Taxpayers of Newton:

In 2014, the Fire Department saw the retirement of two long-time members, Chief William Ingalls with 50 years of service and Captain William Higgins with 28 years of service. Replacing the void created by the retirement of Chief Ingalls is Chief John Alcaidinho. Chief Alcaidinho came on in December and is the former Fire Chief of Dartmouth District One in Massachusetts. He has 33 years of experience in the fire service.

The Newton Fire Department consists of 30 Paid-on-Call professionals staffing two fire stations, Central Fire Station located at 35 South Main Street and the Newton Junction Station located at 29 West Main Street. The members of the department respond to all fire incidents, EMS calls and also provide Fire Prevention courses for the residents.

There were no major incidents during the year however we did see an increase in call volume of 20-25%, with just under 300 calls for the year.

Once again, we are asking the town voters to support a fire department warrant article for the purchase of a 3,000 gallon tanker truck. The department has the majority of the money through its Capital Reserve Fund but needs a minimal amount (compared to the total cost) for the purchase. This will replace our 1983 tanker, which has been out of service since March 2014. The purchase of this tanker will give us an additional 3,000 gallons of water to use in the event of a fire. This is an important factor because Newton does not have a municipal water system with pressurized fire hydrants.

On a safety note, the Fire Department would like to request that everyone display their house number. These numbers should be clearly visible from the street in reflective or contrasting color to the background. Common driveways should have a sign at the street, listing the numbers on that driveway. These numbers are available through the Newton Firefighters Association by calling the Fire Station at 603-382-8811. This could save someone's life!

In closing, we would like to thank the citizens and taxpayers of Newton for their continued support. It is our job to keep the town safe. This is a responsibility that we take very seriously. I would also thank the firefighters and officers (past and present) of this department for your time and effort to make this department what it is today.

FOREST FIRE WARDEN AND STATE FOREST RANGER

Your local Forest Fire Warden, Fire Department, and the State of New Hampshire Division of Forests & Lands, work collaboratively to reduce the risk and frequency of wildland fires in New Hampshire. To help us assist you, please contact your local Forest Fire Warden or Fire Department to determine if a permit is required before doing ANY outside burning. Under State law (RSA 227-L:17) a fire permit is required for all outside burning, unless the ground is completely covered with snow. The New Hampshire Department of Environmental Services also prohibits the open burning of household waste. Citizens are encouraged to contact the local fire department or DES at 603-271-1370 or www.des.state.nh.us for more information. Safe open burning requires diligence and responsibility. 
This past fire season started in early April with the first reported fire on April 7th. April, which is the traditional start to our spring fire season, began very dry with unseasonably dry conditions continuing through the entire month. This dry pattern continued through the first half of May. 80% of our reported fires this season occurred during this six week period. The largest fire was 24 acres, occurring in the town of Tamworth. From mid May through early September, above average rainfall kept our total acreage burned statewide at 72 acres. This is the smallest amount of acreage burned statewide in several years. Late August through late September though brought a dry trend to northern areas, resulting in several deep-burning remote fires. Our fire danger days correlated well with the days that there were fires actually reported. The statewide system of 16 fire lookout towers continues to operate on Class III or higher fire danger days. Our fire lookouts are credited with keeping most fires small and saving several structures due to their quick and accurate spotting capabilities. The towers fire spotting capability was supplemented by the NH Civil Air Patrol when the fire danger was especially high. Many homes in New Hampshire are located in the wildland urban interface, which is the area where homes and flammable wildland fuels intermix. Several of the fires during the 2014 season threatened structures, and a few structures were burned, a constant reminder that forest fires burn more than just trees. Homeowners should take measures to prevent a wildland fire from spreading to their home. Precautions include keeping your roof and gutters clear of leaves and pine needles, and maintaining adequate green space around your home free of flammable materials. EMERGENCY MANAGEMENT

2014 was a good year for our residents. There were no major incidents that occurred which is always a good place to be in. The town did see some small scale power outages, the longest outage lasted approximately four hours. The Town and its employee's will continue to keep up the good work in 2015.

I believe that in Emergency Management, one should always be proactive and not reactive. By doing this, the Town faces no incidents, and when we do face one, we are prepared to deal with it. The Emergency Management Department has obtained a Homeland Security Grant which will be used to update the Emergency Operations Plan. In 2015, the department will apply for a Grant that can be used to update the Hazardous Mitigation Plan.

In 2014 the Seabrook Power Plant had their bi-annual drill with the Federal Government. I am pleased to say that the Emergency Response Team that our Town had in place that day did a wonderful job and achieved a score of an A+ from the State and Federal Government. I would like to thank each and every one of you that were a part of this drill and for making it so successful for our Town.

The Emergency Management Department will continue to apply for grants from the State as needed in 2015. If approved, some of these Grants will be used to update some of our equipment. We will also be using the Grants for training purposes as well.

The Emergency Management Department strives to be a great resource for our residents. If you have any questions regarding emergency preparedness, what to do when an event is approaching or have any other general questions or needs, please feel free to reach out to us. Along with the Local Emergency Planning Committee we promise to serve the Town of Newton and its residents to the best of our ability and look forward to serving you in the upcoming year.

GALE LIBRARY REPORT

We have had another busy year filled with activities and programs for all age groups. It is very gratifying and rewarding for all of us here to serve as your public library. We strive to offer programming and materials for the collection that would be of wide appeal to varied interests. Thank you to the many community members who voted in favor of Warrant Article 6 on March 11, 2014. Your support is respectfully acknowledged and appreciated!

The Friends of the Gale Library have been of great assistance to provide services and the additional needs of the library. In January, the Friends purchased two new HP desktop computer systems with Windows 8 operating system. We have all learned to navigate along within the system by practice and periodic technology workshops.

They have also held book sales, bake sales, offered discounted movie packages, offered discounted entrance fees to York's Wild Animal Kingdom, sold t-shirts, held their annual Christmas basket raffle, and much more. This year, the Friends and Library Trustees also represented the library during Newton Town Day in September. We are very grateful for all they do to promote the library with their enthusiasm and kindness!

A donation of an automated external defibrillator was received this summer from the Newton Fire Department. Thank you to Fire Chief Ingalls for providing this safety device for our visitors. Staff members attended AED/CPR classes in July and First Aid classes in August with Michael Giordano. The device is centrally located near the fire alarm panel box for ease of accessibility.

Building maintenance projects completed this year include the addition of two new energy efficient air conditioners, an upgrade of electrical service to 200 amp, the installation of a new LED outside lamp in the parking area, a hot water heater replacement, carpet cleaning, painting projects, landscaping projects, routine maintenance, and other various projects throughout the year. A structural engineer was consulted in November to inspect the fire exit stairway to ensure the integrity of the unit. It was necessary to discontinue usage of the second floor until the recommended repairs could be made.
