	An adult male in Kingston, NH tested positive with a co-infection of Jamestown Canyon Virus and Powassan Virus. Jamestown Canyon Virus is transmitted by mosquitoes while Powassan Virus is transmitted by ticks.

	In Massachusetts, 12 human cases of EEE including 3 deaths have been reported as well as 426 EEE mosquito batches, 9 EEE animal cases, 2 human cases of West Nile Virus and 86 WNV mosquito batches.
