NEWTON PLANNING BOARD PUBLIC MEETING MINUTES June 8th, 2021

The Newton Planning Board public meeting was called to order at: 7:00PM

Chairman Andrews read the following statement: Due to the State of Emergency declared by the Governor as a result of the COVID-19 pandemic and in accordance with the Governor's Emergency Order #12 pursuant to Executive Order 2020-04, and most recently extended this public body is authorized to meet electronically.

Chairman Andrews appointed Mr. Marchand to vote in place of Mr. White.

1. Public Hearing

Chairman Andrews opened the Public Hearing at 7:03PM and read the following:

Michael J. Bell of Newton, NH request a Public Hearing for a Major Nonresidential Site Plan – a Garage in excess of 1200 square feet at 44A Bear Hill Road, Newton, NH. The property is referenced as Tax Map 17, Block 4, Lot (5-1).

Chairman Andrews asked Ms. Rowden for her input.

Ms. Rowden stated that while there is a requirement in the definitions that any auxiliary building over 1200 square feet needed Planning Board approval; however, the Board does not have a process in place to hear the application and at this time does not have the jurisdiction to make a decision. While the ZBA made their approval of Mr. Bell's variance conditional on him applying to the Planning Board, the Board could neither approve nor deny the application. She stated that Mr. Bell met the conditions of his ZBA approval.

The Board discussed the appropriate handling of the issue.

Ms. Collyer **MOVED** that as of this date, the Planning Board does not have jurisdiction to address this application, therefore the Planning Board cannot render a decision. However, the Planning Board agrees that Mr. Bell has met the condition set forth by the Zoning Board of Adjustments, Mr. Moran seconded the motion.
