

Newton Planning Board Public Meeting Minutes December 14, 2021



The Newton Planning Board public meeting was called to order at: 7:03PM

Chairman Andrews appointed Mr. Marchand as a voting member for the excused Mr. White. **1. Circuit Rider Jennifer Rowden -** overview of the steps for the Land Use chapter of the Master Plan.

Ms. Rowden explained the process and gave her draft overview of the chapter's proposed sections. She further explained that the document needs to have enough information to be of substance without making it too rigid. She covered the format with the potential tables and charts along with her intent to use the results from the resent survey. She discussed the possibility of a public outreach event once the basic work was completed, however she acknowledged that covid would be a factor. The outreach event should be at the end of March or early April as an ideal time to host it.

Shall the voters of Newton authorize the Planning Board to prepare and annually amend a recommended program of municipal capital improvement projects projected over a period of at least 6 years, as provided for in NH RSA 674:5?
