Vice Chair James Doggett arrived to the meeting at 7:18 PM.

- 1. Ground Care Landscaping, LLC, Gregory Cunningham, Manager, 185 So. Main Street (Map 14 Block 1 Lot 25) Minor Non-residential Site Plan (Continuation) Greg Cunningham, Manager, appeared before the PB. Mr. Cunningham wants to run his landscaping business on the property. He proposed creating bins to store organic material such as mulch, stone and sand. All blocks, bins and containers will be a minimum of 25' from the property lines. The hours of operation would be Monday through Saturday 6:30 AM to 7:00 PM. Also, during the winter it would be during, before or after snow/ice events. He would also be using the property to park his equipment. He's proposing putting a gate to the entrance of the property for security. J. Doggett made a motion to take jurisdiction of the application, seconded by C. Melvin with unanimous vote.
